

# **Project 5.0**

## **Baltimore City Health Department & The Office of Equity & Civil Rights: CHARMcares Platform**

**Civic Innovators** is a collaborative program leveraging businesses to partner to solve specific challenges in Baltimore City.

City agencies often have insufficient capacity and resources to take on important projects that could have a dramatic impact on the economy and health of our city. Businesses are uniquely positioned to contribute the technical expertise of their employees to respond to city challenges.

Since 2019, five (5) Civic Innovator projects have been completed. A total of \$445,850 in pro-bono support has been provided to five (5) city government agencies with the help of ten (10) corporate partners and forty-three (43) corporate volunteers.





## >>> The Goal

The goal of the Civic Innovators program is to contribute human capital from the private sector to help solve our city's biggest challenges. Partnering with staff from city agencies, pro bono business volunteers leverage their technical knowledge on strategic projects leading to innovative solutions to critical issues.

## **Project 5.0 Overview**

In the fifth Civic Innovators project (CIP 5.0), corporate volunteers partnered with the Mayor's Office of Equity and Civil Rights and the Baltimore City Health Department to create a centralized referral system for services that would benefit Baltimore City residents. The goal of CIP 5.0 was to conduct the pre-work to enhance the Baltimore City Health Department's CHARMcare referral system.

In July 2024, the project concluded with recommendations from the User Experience and Sustainability workgroups to implement solutions that would address the needs of the next phase of this website resource. The recommendations focused on improving user experience and accessibility, as well as increasing awareness and participation from local stakeholders.

## **Project 5.0 Progress**

Staff members from the Baltimore City Health Department and Office for Equity and Civil Rights joined forces with corporate volunteers to form two (2) working groups focused on User Experience and Sustainability.

Based on the collaborative work of Baltimore City staff and the corporate volunteers, the following improvements to CARMcare were recommended:



#### **Improvements in User Experience & Accessibility**

The User Experience Workgroup hosted virtual and in-person events for users to engage with the CHARMcare platform and provide feedback for improved functionality. Baltimore City requires all websites to be translatable for non-English speakers. The CHARMcare site will need enhancements for non-English users and additional accessibility tools for those with disabilities to comply with ADA regulations. The workgroup also developed a marketing plan to raise awareness about the platform.



#### **Recommendations for Awareness & Funding**

The Sustainability Workgroup has created a workforce plan to sustain the platform, developed a funding plan, and established a vendor engagement plan. The workforce plan recommends recruiting and maximizing the use of interns to maintain the relevance of resources, while the funding plan looks into securing funding from the city and seeking philanthropic support for future software updates and intern compensation. Lastly, the vendor engagement group is concentrating on developing tools to engage potential community-based organizations and city resources.
